

CARROLL ELECTRIC MEMBERSHIP CORPORATION

SCHEDULE OL-3 OUTDOOR LIGHTING SERVICE

PURPOSE

To provide revenue for patrons' electric service and capital from the patrons. In compliance with the Cooperative's principles and bylaws, revenue for electric service is equal to the cost of service provided. All money in excess of the cost of providing electric service is capital, at the moment of receipt, and will be credited to each patron's individual capital account.

AVAILABILITY

Available in all territory served by the Seller in accordance with the Service Rules and Regulations of the Seller on file with the Georgia Public Service Commission.

APPLICABILITY

Applicable only to outdoor lighting fixtures and poles conforming to the seller's specifications for dusk to dawn lighting. Service will be rendered only at locations that, solely in the opinion of the seller, are readily accessible for maintenance and where standard secondary voltage is presently available.

MONTHLY RATE

Part 1- Seller Owned and Maintained System

Section A – Fixtures

Section B – Poles

Poles installed prior to July 1, 2018 for the exclusive purpose of rendering outdoor lighting service will be billed at these rates.

After June 30, 2018, where it is necessary for the Seller to install poles for the exclusive purpose of rendering outdoor lighting service, the consumer will be required to pay, prior to installation, a non-refundable contribution in-aid-of construction (CIAC) in the amount set forth below for each pole.

Section C – Explanatory Notes

- (1) Bills for different premises will not be combined in calculating this charge. A premise is defined as a single contiguous area either owned or controlled by the consumer.
- (2) Where it is necessary for the Seller to install transformers for the exclusive purpose of rendering outdoor lighting service, the consumer will be required to pay, prior to installation, a non-refundable contribution in-aid-of construction (CIAC) in the amount set forth below for each transformer.

| Pole-mount | Up to 10 kVA | \$600.00 |

- (3) Fixtures served by underground wiring will be available at these rates (excluding certain residential areas served by overhead distribution) where required buried cable does not exceed, on the average, 125 feet per fixture. A contribution-in-aid-of construction will be charged amounting to **\$6.00** per foot of the excess buried cable over 125 feet per fixture not installed in a common trench used for primary or secondary electrical circuits. Where underground wiring is desired, and paving, rock or other obstructions exist, the consumer will be required to perform all trenching, install duct furnished by the seller, backfill, and complete repaving to the mutual satisfaction of all parties concerned. The consumer will be required to reimburse the Cooperative for the cost of directional drilling.

Part II – Customer Owned Equipment - Unmetered

Service charge **\$24.00** per location

Notes:

- (1) Carroll Electric Membership Cooperative may, at its option, verify kWh by installing a kWh meter or load limiting device.
- (2) The number and location of service points shall be specified by the Cooperative.
- (3) In no case shall the Cooperative spend more than two-and-one-half times estimated annual revenue to be derived from this service. The term “customer owned equipment” means complete ownership by the customer of all facilities including poles, fixtures, circuits and disconnect devices up to a point of connect of the Cooperative’s supply lines. The customer shall provide a suitable mounting and wiring for a Cooperative supplied photo electric receptacle and a weather-proof enclosure, if needed, for any Cooperative supplied relay. The Cooperative may, at its option, require the customer to supply the photo electric control.

TERMS OF PAYMENT

The above rates are net. The bill is payable upon receipt and due by the date shown on the bill.

TERM OF CONTRACT

A period of not less than one (1) year for Yard Lights and a period of not less than five (5) years for all other lights.

FACILITIES CHARGE RIDER

A facilities charge will be added to the basic rate for the investment in facilities in excess of that which is normally required to furnish demand and energy to customers under this rate schedule. The facilities charge will be calculated as the dollar investment in facilities times a fixed monthly charge rate.

INTEREST DURING CONSTRUCTION-ENVIRONMENTAL RIDER (IDC)

This Cooperative’s rates are prepared to recover the actual cost of wholesale power based on projected amounts. Wholesale power costs may be impacted by additional costs, including interest to construct new resources, deferred expenses/interest on new/acquired resources, and government mandated environmental costs/upgrades. In order to assure that power costs are neither over-collected nor under collected from the members and to manage projected costs, rates may reflect IDC charges in subsequent rate schedules.

TAXES

In addition, the Consumer will pay the amount of any sales, use, franchise or utility taxes for charges now or hereafter applicable to or arising out of the service rendered or made available under this schedule, which tax shall be added to each bill; unless the Consumer furnishes satisfactory evidence that it is exempt here from.
